1. RESIDENTIAL:

2. COMMERCIAL/NONRESIDENTIAL:

A one-time sewer capacity fee (separate from the monthly charge) of up to \$3.00 per gallon of sewage that each facility is anticipated to generate will be assessed in accordance with the following schedule:

Any use not listed will be placed in the most appropriate category. Appeals may be made to the Board of Aldermen. During this time, the City will hold the required fee until average daily figures of actual usage are available.
