



Republic City Council Member Application

This application is for Republic residents of Ward III interested in serving on the City Council. The application is due to the City Clerk's office on August 25, by 3:00 p.m.

APPOINTMENT AUTHORITY/DUTIES:

Appointment: Filling of Vacancies. A vacancy in the Council shall be filled for the remainder of the unexpired term, if any, at the next regular municipal election, but the Mayor with the advice and consent of the Council may fill the vacancy until the person elected to serve the remainder of the unexpired term takes office.

Qualifications: A Council Member shall be a citizen of the United States and a resident of the City for one (1) year at the time of appointment. A person must be a resident of Ward III at the time of appointment for office and must be a registered voter in that Ward and must remain a resident of the Ward during the time of service as an appointed official of the city.

Duties of the City Council:

(a) **Holding Other Office.** Except where authorized by law, or pursuant to an agreement between the City and another entity of government, no Council Member shall hold any other City office or City employment during the term for which he/she was elected/appointed to the Council, and no former Council Member shall hold any compensated appointive City office or City employment until one (1) year after the expiration of the term for which the member was elected.

(b) **Interference with Administration.** Except for the purpose of inquiries, information, and investigations under Code Section 3.9, Investigations, the Council or its members shall deal with City officers and employees who are subject to the direction and supervision of the City Administrator solely through the City Administrator, and neither the Council nor its members shall give orders to any such officer or employee, either publicly or privately.

(c) **Taxes and Fees.** The City Council shall, from time to time, provide by ordinance for the levy and collection of all taxes, licenses, impact fees and other duties not herein enumerated and for neglect or refusal to pay the same, shall fix such penalties as are now or may hereafter be authorized by law or ordinance.

(d) It shall be the duty of each member of the City Council to be present at each meeting of the Council unless leave of absence is granted, or such member is sick and unable to attend.
